How to Get a Queue Number via mobile phone (1/2)

#1. Access SYC Portal

- You can connect to Wireless@SG if needed (refer to Wireless@SG connection guide)

#2. Log In

- For Singaporeans, PRs or foreigners with SingPass: Click “Login via SingPass”
- For Lawyers: Click “Login via CorpPass”
- For Foreigners without SingPass: Click “Login via SYCPass”

#3: Get Your Queue Number

Once logged into the SYC Portal, click on the “Queue Request” tab.

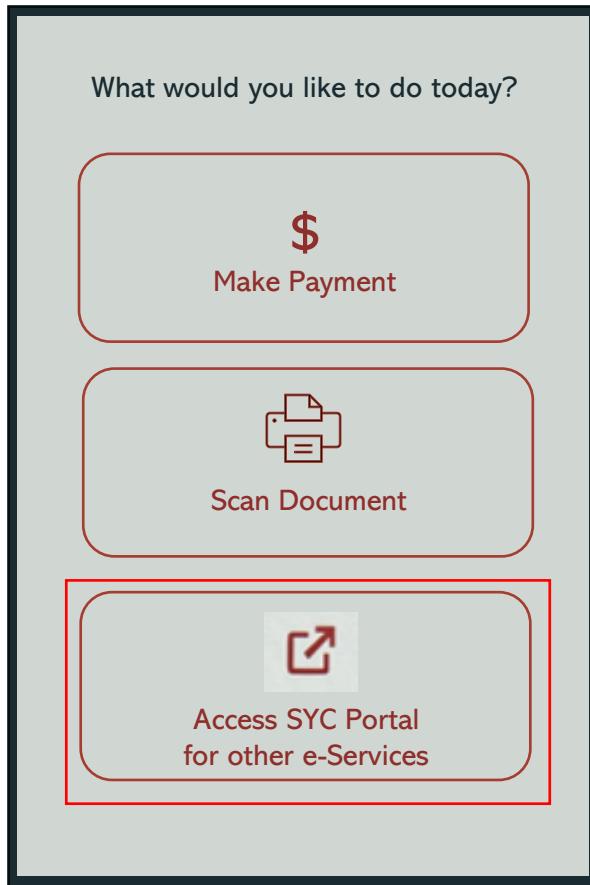



1. If you have an appointment scheduled, you may register your attendance 30 minutes before the start of the appointment by selecting 3 dots under "More Options" tab to "Get Queue Number" or "Check-in". You must check-in to confirm your attendance.
2. If you do not have a court appointment or have missed your court appointment, please select "Request Walk-in Queue Number".
3. Last queue ticket will be issued at:
 - Mondays to Thursdays: 12:30 PM and 4:30 PM
 - Fridays: 12:00 PM and 4:00 PM
