

IN THE SYARIAH COURT OF THE REPUBLIC OF SINGAPORE
REGISTRAR'S CIRCULAR NO. 1 OF 2026
IMPLEMENTATION OF FURTHER NEW E-SERVICES

1. Further new E-Services will be implemented through the SYC Portal on the Syariah Court's website on the dates set out below or such later date as the Court may direct.

	<u>Description of E-Services</u>	<u>Implementation date</u>
(a)	Filing of originating summons for nullity and its accompanying documents	13 August 2026
(b)	Filing of originating summons for all other applications under the Administration of Muslim Law Act and its accompanying documents	13 August 2026
(c)	Filing of all documents in non-divorce proceedings, including documents in a proceeding under section 46A(4) of the Administration of Muslim Law Act ("AMLA")	13 August 2026

E-Service in paragraph 1(b)

2. The originating summons in paragraph 1(b) does not include an originating summons for divorce, nullity or an application pursuant to section 46A(4) of AMLA which must be filed using the respective E-Service for each such originating summons.

3. The application which may be filed using the E-Service in paragraph 1(b) must be an originating application and includes an application under sections 51, 52(1) and 52(2) of AMLA where there has not been any proceedings for divorce or nullity of marriage between the parties in the Court, sections 54 and 101 of AMLA, or any other provision in AMLA, whether in the current or subsequent versions, for which there is no other specific E-Service in the SYC Portal. Reference is made to rule 9(2) and any other applicable rule of the Muslim Marriage and Divorce Rules in respect of the mode of commencement of such applications.

E-Service in paragraph 1(c)

4. To avoid doubt, the non-divorce proceedings referred to in paragraph 1(c) refers to proceedings commenced by filing an originating summons using the E-Service in paragraphs 1(a) and (b) and the E-Service for an application pursuant to section 46A(4) of AMLA.

5. The documents to be filed under paragraph 1(c) include the following:
- a. all affidavits;
 - b. all notices;
 - c. all summonses, including amended summons;
 - d. amended case statement for nullity, memorandum of defence for nullity and amended memorandum of defence for nullity;
 - e. certificate under section 17 of the Legal Aid and Advice Act;
 - f. grant of aid and provisional grant of aid; and
 - g. any other document required to be filed in the proceedings.
